Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice. If swallowed call a poison control center or doctor immediately for treatment advice. If inhaled, move person to fresh air and call a poison control center or doctor for treatment advice.
